Vide notification no. DPLD/2/2011/34 dated 14<sup>th</sup> June, 2010 received from Financial Commissioner, Rural Development & Department of Panchayats, Punjab, Chandigarh vide its letter no 15/12/10/LD-2/1331-32 dated 09/07/2010. The undersigned has been delegated the powers to gift the Shamlat Deh land for construction of buildings of various departments of the Punjab Government. I, Yashvir Mahajan, IAS, Deputy Commissioner, Fatehgarh Sahib do hereby give the approval of gifting the following land to Kendriya Vidyalaya:-

Rural Development & Panchyat department Chandigarh vide their memo letter No. 15/12/10 L.D.-2/1331-32 dated 9.7.2010 and notification No. D.P.L.D. 2/2010/34 dated 14th June, 2010 in which undersigned has powers to donate any shamlat land for the construction of building of any department of Punjab Govt. as per that powers permission has been granted to donate/ gift the shamlat land khasra No. 2//19min(4-13), 20min(4-13), 21(8-0), 2//22(8-0), 3//16min(4-13), 17min(3-0), 24(7-6), 25(8-0), 1//1(8-0), 2(8-0), 9(8-0), 10(8-0) khasra 12 measuring 80 Kanal 5 Marlas to Kendriya Vidilya Reona Ucha.
